

### From Orlando International Airport:

Take the North exit to State Road 528, Beach Line Expressway (toll road) West. Follow 528 until you reach I-4. Go West on I-4 to exit 64, US 192 West bound. Continue West on US 192 for 8.5 miles. Make a Right on Town Center Blvd (will be one block West of Summer Bay Resort Blvd). Our Welcome Center entrance will be next to the Denny's restaurant.

## From I-95 North:
