**From North**  
Take I-35 S. Merge onto I-410 West/ Texas Hill Country Trail VIA EXIT 166. Take EXIT 148 toward Callaghan Rd onto NW Loop 410 access road. Take the turnaround at the light on Callaghan onto NW Loop 410. Stay on the access road. Take a right hand turn quarter mile up.

**From South**  
Take Interstate 35. Merge onto I-35 N via the ramp on the left. Merge onto I-410 N via EXIT 145A. Take EXIT 17A toward Cherry Ridge Dr. Merge onto NW Loop 410. Keep left at the fork to continue on NW Loop 410. Turn left to stay on NW Loop 410. Keep right at the fork to continue on NW Loop 410. NW Loop 410 becomes W Interstate 10.

**From West**  
Take onto W Loop 1604 N/W Loop 1604 N becomes N Loop 1604 W. Turn slight left to take the TX-1604 Loop E ramp. Merge onto TX-1604. Merge onto I-10 E/US-87 S toward San Antonio. Take EXIT 562 toward Callaghan Rd/Medical Dr. Merge onto W Interstate 10.
