## **TOUR QUALIFICATIONS—VICTORY MARKETING**

Must be a married or cohabitating couple or single individual meeting the requirements below:

- Must agree to attend and complete a timeshare Tour of at least 120 minutes (together for all married or cohabitating couples);
- · Must be either a U.S. or a Canadian citizen;
- Must be currently employed full-time or retired, and cannot be a full-time student;
- Upon check-in, must present: (i) an original ResortStay provided and approved invite that has been fully and accurately completed in all respects; and (ii) a valid unexpired government-issued photo identification;
- Married couples must present either a major credit card or a major U.S. bank-issued debit card linked to a
  personal checking account;
- Unmarried cohabitating couples and singles must present a major credit card;
- If a married couple with a major credit card, one individual must be within the age range of 25 to 72, and the spouse must be at least 25 years old, and the couple must have a combined gross annual household income of at least \$50,000.00;
- If a married couple with a debit card or an unmarried cohabitating couple with a major credit card, one
  individual must be within the age range of 30 to 60 and the other must be at least 25 years old, and the couple
  must have a combined gross annual household income of at least \$75,000.00;
- If single, must be a female in the age range of 30 to 60 and must have a gross annual household income of at least \$75,000.00;
- If a married or cohabitating couple, must be cohabitating with each other, evidenced by valid unexpired government-issued identifications showing matching addresses;
- Must have at least one member of the touring party who is able to speak and understand English, in both verbal and written form;
- Only one qualified couple or single may participate in each Tour—quinellas are not allowed, unless expressly approved by Sales management; (singles may be accompanied by a companion traveling with them);
- Cannot have previously toured within the preceding 12 months and cannot be a current owner in GeoHoliday Club or Sapphire Resorts;
- Cannot have already been booked for a Tour by employees or contractors of ResortStay, any of ResortStay's affiliates, or any other marketing vendor of ResortStay or its affiliates;
- Cannot have been scheduled, and cannot thereafter be scheduled, by Victory Marketing's personnel to attend any other timeshare, travel club, or vacation club sales presentation:
- Cannot reside within 60 miles of Las Vegas, Nevada;
- Cannot be an employee of ResortStay, Starpoint, RCI, Interval International, Victory Marketing, any of Victory Marketing's contractors, employees or affiliates, or any other timeshare developer or marketing company;
- Cannot bring any children under the age of seven (7) to the Sales Office;
- Cannot bring any alcohol to the Sales Office, and no prospect or guest presenting for, or participating in, a
  Tour may be under the influence of alcohol or any controlled or illegal substance under state or federal law;
- Must have arrived at the Sales Office at least ten (10) minutes prior to the scheduled Tour time. (If a prospect
  fails to timely arrive, Sales management may, in its sole discretion and on a case-by-case basis, decline the
  prospect the opportunity to Tour, allow the prospect to participate in a Tour at the originally scheduled time,
  or reschedule the prospect for a Tour at another time.)
