Qualifications:

- Must agree to attend and complete a timeshare sales presentation ("Tour") of at least 120 minutes (together for all married or cohabitating couples).
- Must be currently employed full-time or retired and cannot be a full-time student.
- Married couples must present a valid unexpired government-issued photo identification and a major credit card (debit cards are not accepted as a 2nd form of ID).
- **NEWLYWEDS MUST HAVE THE ACCEPTABLE MATCHING ID OR THEY MUST HAVE THE ORIGINAL COPY OF THE MARRIAGE LICENSE (NO PHOTOCOPIES, EMAIL, IN THE CELL PHONE)**
- If a married or cohabitating couple: one must be within the age range of 28 to 75 and have a combined gross annual household income of at least \$60,000.00; (\$50,000 if both are retired). **No Singles.**
- If a married or cohabitating couple, must be cohabitating with each other, must provide valid unexpired government-issued identifications showing matching addresses.
- No quinnellas or group travel.
- Guest must be Only leg or 2nd leg tours
- Only US and Canadian citizens excepted (Quebec accepted) . ALL in the party Must be able to speak and understand English fluently, in both verbal and written form.
- Cannot have previously toured the resort within the preceding 12 months and cannot be a current owner of Spinnaker Resorts.
- CANNOT Own real estate in Volusia County, No Flagler County Residents
- Cannot be an employee of Spinnaker Resorts, II, RCI. any other Timeshare Company, the marketing vendor or any of vendor's contractors, employees or affiliates, or any other timeshare developer or marketing company.
- Reservations must be canceled or rescheduled at least 72 hours prior to arrival date, failure to cancel or reschedule within 72 hours will result in vendor being charged back for 1 room night plus tax. Reservations are not processed on Saturday or Sunday including cancellations and reschedules.
- Any guest that checks into the hotel but fails to attend the presentation or any guests not meeting the qualifications will result in vendor being charged back for all room nights.
