LOCATION SPECIFIC MINI VAC AGREEMENT

Location: Poconos (East Stroudsburg), PA.

Incentives: 2 nights stay.

Tour Pay: \$150.00 per qualified tour.

A qualified prospect shall be defined as follows:

- a. This mini vac program is available to prospects who are married or cohabiting couples only. This program is not available to single men or single women.
- b. Guests will be staying at Pocono Mountain Villas by Exploria Resorts. Up to 2 extra nights can be requested and the room rate will be provided to you before confirmation.
- c. All participants must be US residents and must be at least 28 years of age with income of \$70000. Couples must complete the presentation together.
- d. Upon arrival, prospects will be required to present two forms of identification, a valid Driver's License, or governmental ID along with a major credit card (Visa, Master Card, American Express or Discover). Children are allowed at the presentation.
- e. Prospects may not already be an owner of a vacation ownership with Exploria.
- f. Prospects must complete the 90-minute travel presentation in English.
- g. All Prospects must agree to undergo a soft credit screening. Any prospect that does not meet the minimum credit criteria and other qualifications established by Exploria, in its sole discretion, may not be eligible to attend a timeshare sales presentation and will not receive any Gifting Premium.
- h. Prospects must not have attended a timeshare sales presentation at any Exploria Property within the past 12 months. Maximum lifetime limit of two (2) timeshare sale presentations allowed for any prospect.
- i. Prospects may not be scheduled for any other Timeshare presentation while touring Exploria sponsored travel package.
- j. No person may have an active bankruptcy. Employees or family members or agents of Contractor or Exploria or their respective parent and affiliated companies are not permitted to attend a tour.

- l. All reservations require credit card at time of check in and a security deposit of \$250.
- m. If cancellations are received less than 5 business days prior to arrival, a \$100 fee will be charged.
