**HOUSEKEEPING SERVICES:** Beach Vacations provides an initial set up and departure maid service. **Daily, Midweek, Towel and Trash Services** are available upon request at an additional charge. Please see the Front Desk for scheduling and pricing. HOA Regulations prohibit trash to be left outside of any unit.

**SECURITY DEPOSIT (Choose One):**

- OPTION A:** I elect to be charged the \$39.00 Damage Waiver Fee (Plus Tax) - I understand that this fee is a non-refundable charge that covers up to \$1,000 of reported instances of accidental or non-negligent damages. In addition, guests are not required to put down a security deposit at time of arrival.
- OPTION B:** I elect to have my Credit Card pre-authorized in the amount of \$100. I understand that this is refundable provided there are no missing items or work orders opened in direct correlation with my stay in the condo. I understand that this authorization may take (7) seven to (14) fourteen days from my departure date to be released depending on the card issuer. Pre-paid credit cards are not accepted for this deposit.
- OPTION C:** I elect to pay \$100 in cash - I understand that this is refundable provided there are no missing items or work orders opened in direct correlation with my stay in the condo. I understand that this will be refunded as a check (4) four to (6) six weeks after my departure date.

**PROPERTY POLICIES:**

- I understand I am held responsible for the well keeping of the condo, its contents and the linens. I will report any damages immediately upon check-in. I understand if there are missing items or work orders opened in direct correlation with my stay in the condo, my credit card will be charged for the amount of the said loss.
- Motorcycles, boats, trailers, RV's and golf carts are not allowed on property.
- If after hours access to unit is required due to a LOCKOUT or LOST KEY, the **GUEST will incur a \$65.00 charge.**
- Parking is limited to **two (2)** automobiles per condo
- I agree to check out of Beach Vacations Condo / Golf Villa / Townhome by **10:00 AM** on departure date as stated above.
- I understand that late check outs will result in an additional night stay.
- I agree that I am at least 21 years of age and responsible party for this agreement.
- I understand that there are **NO REFUNDS** for early departure.
- By virtue of the Inns keepers Law of S.C., I understand that the company cannot be held responsible for articles, valuables, or money left in guest room. If you do not follow set guidelines for behavior, you may be subject to fines and/ or eviction
