The official confirmation letter has been attached to this letter. In all we were three (3) couples who went to Las Vegas for three (3) nights. This letter is written on behalf of all of us.

We called in response to your internet Ad to book a \$99.00 promotion per room for 3 nights in Las Vegas. Instead, we were advised to buy another promotion for \$106.59 per room for a total of \$319.77 for all 3 rooms and for 3 nights stay at Rio suites. We were also told to pay additional \$35.00 per room for all three (3) nights in taxes to Rio on check in i.e. another \$105 for all 3 rooms and for all 3 nights as hotel fees. Making it a total of 424.77 for all 3 rooms for all 3 nights to attend a sales presentation and an opportunity to buy a piece of real estate (like time share) in Vegas.

We had no plans to go to Las Vegas, but this opportunity attracted us.

When we arrived at Rio, it was a total mess, self-check in, very long lines, very slow and no help. Your confirmation number only allowed us to check in one room. It denied when tried to do other two rooms. It took us another 3 hours to get help to check in and get the other two rooms. Also they charged us a total fee of \$407.70 for all three rooms instead of \$105.00 which was told to us. Also, there were no microwave in any of the rooms which was also promised being suites rather than just common rooms.

Next day on 25th of October, we all went to Jockey club on time for presentation.

Unfortunately to our surprise, only two (2) couples were admitted first and later on they were denied attendance due to our age. We strongly feel that we were discriminated against attending the presentation because of our age. We also feel that we were excessively charged by Rio i.e. \$407.70 instead of \$105.00 for fees, and there was no microwave in the rooms as promised forcing us to eat expensive meals outside.

In all fairness, Room101.Com failed to meet their obligations at Jockey Club presentation and stay at Rio as promised. You owe us a full refund of \$727.47 (319.77 + 407.70) for failed obligations. Please refund the full money of \$727.47 back to us ASAP.
